Rev. Paul Peverell welcomed everyone to the meeting and opened the meeting with a prayer.

The Rev. Paul Peverell (Chairman) and 11 attendees whose names are entered on the Electoral Register.

**MEETING OF THE PARISHIONERS**

**I. ELECTION OF CHURCHWARDENS**

Due to the Coronavirus Pandemic nomination forms for Churchwarden had not been completed. Therefore nominations were taken from members attending the meeting. Mrs Christine Stinson and Mr Matthew Hulbert indicated that they were willing to continue as Churchwardens. Mrs Jancie Brown proposed that both existing Churchwardens continue in their roles, this was seconded by Mrs Wendy Fordy. All members were in agreement and so the aforementioned were duly appointed.

Rev Paul Peverell thanked both Matt and Chris for their ongoing work in making St. Oswald's a welcoming and safe church for worship for everyone. He also thanked their spouses for their support too. He gave thanks to John Stinson for his hard work in keeping the grounds of St. Oswald's always looking immaculate and cared for.

It was agreed that the formal acceptance of the Church wardens will take place within the service at St. Oswald's on Sunday May 2<sup>nd</sup>. The Churchwardens will also be formally accepted within the Diocese at a service in York Minster on Monday June 14<sup>th</sup>.

**2. MINUTES OF THE LAST MEETING 23<sup>rd</sup> June 2020**

*(as printed in the Annual Report )*

The minutes were taken as read. Mrs Jancie Brown proposed that they were accepted as a true record. This was seconded by Mr John Stinson. All present at the meeting were in favour that the minutes were a true and accurate

record and were approved. Rev Paul Peverell will sign the approved minutes when next at St. Oswald's Church.

### **3. MATTERS ARISING**

There were no matters arising.

### **4. ELECTORAL ROLL REPORT**

Mrs Jancie Brown, in her role as Electoral Roll Officer, reported that this year was just an updating procedure. There are six new additions to the Roll, giving a total of 47 on the current Electoral Roll.

### **5. PRESENTATION OF THE ANNUAL REPORT FOR 2019**

The report was printed prior to the AGM and had been available as an attachment on an e-mail, sent by Rev. Peverell to all Church members. A printed copy had been sent by post to those Church members without internet facilities.

Rev. Peverell explained that reports had been received from officers of the PCC as well as our Deanery representative, Safeguarding Officer and the Vicars Report. Rev. Peverell thanked officers for their reports which had highlighted a very different and sometimes challenging year for St. Oswald's Church and its congregation.

Mrs Jancie Brown proposed acceptance of the document. This was seconded by Mrs Jackie Short and agreed unanimously by all members present.

### **6. FINANCIAL REPORT AND PRESENTATION OF AUDITED ACCOUNTS**

The Audited Accounts and Treasurer's Report for the year ending 31<sup>st</sup> December 2020 were published in the Annual Report, having been prepared by Mrs Jackie Short. She presented the Financial Statement to the Auditors and was the signatory on the audited accounts. Mrs Lois Neesham-How proposed that they were accepted and this was seconded by Mrs Christine Stinson. All members were in agreement. Rev. Paul Peverell thanked Mrs Jackie Short for her report and hard work in preparing the accounts, in difficult times for finance within the church. Mrs Short commented on the great value of regular giving through Standing Orders to ensure a definite amount of money is contributed each month towards the church funds. The finances over the last year are in a healthy position despite the negative impact of the pandemic on regular church services.

### **7. VICAR'S COMMENTS**

Rev Paul Peverell commented that 2020 had been a very different and strange year as a result of the Coronavirus Pandemic. St. Oswald's Church was closed for 5 months of the year and many of the Christenings and Weddings were postponed to new dates in 2021. Sunday services were streamed using Zoom and this had been very successful in maintaining links with the congregation of

St Oswald's Church. The online services were well 'attended' and provided an opportunity for people to 'meet'. Once the decision was taken to open the Church again, some members of the congregation were able to attend 'in person' whilst others preferred to remain on line as a result of Paul using ZOOM within the church building. Paul commented that it had been a challenging year but he, and we as a congregation, have learned new things through different worshipping experiences. Paul thanked everyone for keeping the faith and attending church when it was appropriate, or through Zoom.

Paul commented that in 2020 Jane Robson joined as Curate for Ayton and Newton. She is to be ordained at Christ Church, Great Ayton on Sunday July 4<sup>th</sup>. Jane thanked everyone for making her feel so welcome at St. Oswald's.

#### **8. ELECTION OF PAROCHIAL CHURCH COUNCIL MEMBERS**

Ms Hannah Mackay is due for re-election to the PCC. Mrs Lois Neesham-How proposed that Hannah be re-elected. This was seconded by Mrs Wendy Fordy. All members present were in favour and so she was duly re-elected as a member of the PCC for a further three years. As Rev. Jane Robson has joined the PCC, it now has a full complement of members.

#### **9. APPOINTMENT OF INDEPENDENT EXAMINERS.**

Mrs Jackie Short proposed that Baldwins Azets Chartered Accountants continue to be the appointed Accountants for the future inspection of accounts. Mrs Jancie Brown seconded this proposal and it was unanimously agreed by all members present.

#### **10. ANY QUESTIONS ON CHURCH MATTERS FOR CONSIDERATION BY PCC.**

There were no questions and so the chairman closed the meeting, thanking everyone for their attendance.

Mr John Stinson proposed a vote of thanks to the vicar. He thanked Rev Peverell for keeping members of the St. Oswald's Church well supported during the pandemic, through ZOOM, Spire and personal contacts. Despite many challenges through 2020 he has kept 'his flock' together. Now that we are beginning to see the light at the end of the tunnel John thanked Paul for the guidance, enthusiasm and dedication he has shown during the last year. It was commented that it was testament to Paul's support that we were still altogether and looking forward to the future and being able to worship within St. Oswald's again.

Rev. Paul Peverell replied that it is always a joy to be vicar of St. Oswald's and thanked everybody for their support.

## Hon. Secretary's Report



2021 was a year of changes within the country and within our church. Moving forward following the COVID restrictions of 2020 we had times when we were able to worship together in St. Oswald's and times when we were still using ZOOM. Thanks to Rev. Peverell's constant commitment and creativity, worship continued throughout the year, allowing people to come together on Zoom or at St. Oswald's, as they felt comfortable. Slowly the full life of the church is getting back to normal with weddings, christenings, funerals and the Sunday services.

PCC meetings took place during 2021, but with changes in the format. The meetings held on January 25<sup>th</sup>, March 1<sup>st</sup> and June 7<sup>th</sup> all took place using the IT facility ZOOM as a means of getting together to discuss the future of worship in St. Oswald's and ensuring that the building remained safe and secure for regular worship. On August 23<sup>rd</sup> and October 11<sup>th</sup> the PCC meeting took place in Christ Church Coffee Lounge, as members felt that it was safe to meet together in person again. The Annual Meeting took place using Zoom and this was held on April 12<sup>th</sup>. There was an extra PCC meeting on Nov. 29<sup>th</sup>, using Zoom, so that members were able to discuss the Freewill Offer to the Diocese.

All meetings have been well attended. However, during the year sadly two members resigned their position on the PCC due to changing personal circumstances. Their roles and responsibilities were assumed by other members of the PCC. The PCC continues to work effectively as a team, with insightful guidance from Rev. Peverell. The team continues to support each other and to support Paul, our vicar, and the congregation. Discussions at PCC meetings revolved around the continuing work and worship at St. Oswald's Church and helping it and its congregation move forward. It was reported at the Annual Meeting that the Electoral Roll had increased to 46. St. Oswald's is blessed with a growing congregation.

As PCC Secretary and Churchwarden it was my responsibility to apply to the Diocese for Faculty permission to install a water supply to the church. This Faculty was granted on January 22<sup>nd</sup> 2021 and the work began and was completed during April 2021. A second Faculty application was submitted in April to install lighting on the entrance path and to refurbish the vestry with a kitchen facility. This Faculty was granted on June 29<sup>th</sup> and work began in October to enable these improvements to the church building. All work was completed, excepting some minor decoration, by early December, so that we were able to enjoy using the kitchen facilities over the Christmas period.





St. Oswald's continues to be a welcoming church thanks to all the hard work of the members of the PCC and by the very supportive congregation. As always, as a resident of Newton-under-Roseberry, it is a privilege to serve as Secretary to the PCC and Churchwarden and to be part of such a caring and welcoming church community.

## CHURCHWARDENS' REPORT

It's been an absolute joy to see Saint Oswald's re-open its doors and welcome back the congregation both old and new. After enduring many difficult months of restrictions, we're delighted that we can now worship within the walls of our beautiful historic church. We'd like to take this opportunity to thank both Paul and Jane for their perseverance, their tenacity and their commitment to ensuring that as a congregation we were able to continue to meet via Zoom throughout lockdown. All their efforts have ensured that church remained connected to the community and as such are has continued to grow, welcoming new followers into our faithful parish.

## Stokesley Deanery Synod

2021 saw significant changes in key roles. At the beginning of the year Tessa Stephens, Vicar of Nunthorpe, took over from Clay Rowntree as Area Dean. John Dickinson from Great Ayton was appointed Lay Dean in June. In October Liz Taylorson was appointed as Deanery Secretary.

The Deanery role is becoming increasingly important. The Archbishop said of the Diocese that as a Church we are getting smaller, older and poorer. Unless we find a way of reversing that trend the organisation that we call Church will fade away. The main business of Synod during 2021 was Living Christ's Story (LCS) which is the Diocesan programme to address the issue. Basically we are charged with making disciples and we are not doing a very good job. Our operating model is broken, so how do we build a new one based on the first principles of our faith? How do we engage with more people and show them the relevance of Jesus Christ to their daily lives?

At the beginning of the year a new consultation process was launched under the LCS banner. This saw each parish being asked to consider its priorities. Across the Deanery the results were consolidated and give an insight into the way we are, collectively, thinking.

I decided this year to step down from Deanery Synod and have been co-opted onto the PCC to fill one of the vacancies. Thank you for the chance to represent St Oswald's

month of Freewill offer to the Diocese due to a mix up with Standing Orders, but then intentionally gave another £1,000 and increased our offer for this year as an appreciation of blessings received.



Sadly we lost two faithful members. Tim Willis, former PCC Secretary, died in August, and David Carter, our Christmas Narrator for many years at the All Age Service, suffered a stroke and died in January this year. We will miss them both for all they offered of themselves for Saint Oswald's.



Just as Tim and David - and many others through the years have appeared by God's grace to keep the life of our Church going, so we are grateful for the new people joining us and the faithful support of many older members, and especially that they all get on so well together. Team Oswald!

**Independent Examiner's Report  
to the Trustees of the PCC of St Oswald's Newton under Roseberry**

I report on the accounts of the charity for the year ended 31<sup>st</sup> December 2021 which are set out on the following 3 pages.

**Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

**Basis of independent examiner's report**

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below.

**Independent examiner's statement**

In connection with my examination, no matter has come to my attention:

- 1 which gives me reasonable cause to believe that, in any material respect, the requirements:
  - to keep accounting records in accordance with section 130 of the 2011 Act; and
  - to prepare accounts which accord with the accounting records and comply with the accounting requirements of the 2011 Acthave not been met; or
- 2 to which, in my opinion, attention should be drawn in order to enable a proper understanding of the accounts to be reached.
