A Word from the Vicar



Little did we realise when writing this report last year as to how the world and Church life would have changed so dramatically in such a short space of time. In hearing of the Wuhan "Flu" in January we were astonished by the speed in which the country came to a Lockdown from March to the end of June, and all the challenges that have happened since.

Within a week of the first lockdown starting we had learnt how to stream services on Zoom and Facebook and not only had the Sunday Worship up and running again, we also started a new Daily Prayer that has grown considerably over the time and now involves a team from both other Churches within the village as well as others from outside. We get 40-50 live attendees with view in Facebook exceeding 200 during the day, and sometimes a lot more. All of our streamed services are going to far more people than before and we keep hearing of new people who listen every day or Sunday.

The Online worship has helped to bring both this Parish and the neighbouring one of Stokesley together during the vacancy in their parish. There is a buzz on the Zoom screen before the service and folk have got to know one another. We have also had people attending the other Church!! The success of this means it will be hard to lose new friends made, so we will be talking with the new priest, Ben Gunter, as to how we can keep some links going.

Sunday numbers between the Churches have included up to 40 actually present, when buildings have been allowed to be open, around 70+ on Zoom, and a far larger number joining in throughout the day on Facebook. We have many regular participants from outside the area, including some in France, Ireland, Romania and New Zealand – that we know about.

Funerals have continued, although the initial restrictions in the first lockdown were most draconian with only 6 mourners allowed. Thankfully that has been increased to 30, and we have used the facility to Zoom services from Church to allow greater participation and can also record services in Church. We have had 49 funerals this year, which given it being a pandemic year, is below the number for several recent years, so we have been fortunate.

Weddings The majority of weddings had to rearrange to 2021 because their Reception Venues were closed, so only 4 weddings took place this year. Despite restricted numbers in Church, we Zoomed services to France, the USA and various

places in the UK, and all were very happy occasions. Zoom has been such a blessing throughout. Its hard to think what it would have been like without it.

Baptisms were the biggest casualty of 2020 with just one taking place and all other couples postponing until safer times.

Online Presence Lots of things have transferred Online from Family Services and Study Courses to Christmas Carol Services and Memorial Services. It has been heartening to see both Midnight Mass and the Christmas Carol Services have been viewed I.5K times each, as well as high figures for other occasions ie Remembrance Sunday when official Parades were banned. We were one of the few communities locally that still had the wreath laying ceremony take place at the same time, but with only a few people present.

The Church website was changed at the end of the year to a format that can be read more easily by mobile phones and it continues to get many hits for information. Facebook Posts are now available on the Front page. We also have started posting details of Funerals on Facebook and this has been much appreciated by the community and the families concerned.

Spire has continued to be well used and received in 2020. Due to the restrictions at the beginning of Lockdown it was decided not to have a paper version for April, but we resumed in May with many useful details for those without Internet access. We hope Spire continues to be both informative and interesting as a Magazine that seeks to bring Church and Community together.

Physical Presence We have kept Christ Church open on Sunday afternoons for Individual Prayer and donations for Middlesbrough Foodbank or special appeals and managed each day in the run up to Christmas. We hope to be able to return to leaving Church open unmanned every day. I have been there personally on Sundays and it has been a good place to be to talk/listen to those who need it, to read and pray in the quiet times, and even to help folk out with their technology. A team of volunteers have also been in regular phone contact with the housebound and during the first lockdown we have a scheme running to collect groceries and prescriptions.

In 2020 we also welcomed **Revd Jane Robson** as our Curate to train in the Parish. It hasn't been the easiest of times to start a new job, but she has got involved really well and regularly helps lead Prayer for the Day and other services, leading Family Worship and encouraging our younger families. Jane has also been much appreciated by families having funerals and has shown great empathy and professionalism. We have got a good one!

This last year has seen some faith stalwarts step down from roles as they needed to shield. Gordon and Dorothy Wood handed over the running of our Foodbank Collections after starting the monthly collections on the 3rd Sunday. These have grown and grown. Ruth Waterton also stepped down from organising the volunteers for leading Intercessions, a role she has faithfully done for 20 years. The onset of Zoom Services shared between Ayton & Stokesley provided the ideal time. As many of the volunteer cleaners were in the "at risk" group and the Church has been shut for 6 months in the last year, Jan Thompson & Irene Reah stepped down from organising the Church cleaning. Jan has kindly helped us a few times since, the Hall cleaners have also helped but we have had several changes there, and I have also run around with hoover and sanitizer. The big loss last year was when **Ewan Murray**, our very talented young organist, was accepted into Birmingham Royal Conservatoire to study organ in September. He has been a great blessing and helped enormously keep the music side of worship ongoing as we moved onto Zoom using his musical and computer talents. We start the new year in good heart and better prepared for what surprises may be in store as we continue to be a Christian presence in our village and beyond.

PCC Secretary Report 2020

We have had a few challenges in this last year. I took over as PCC Secretary to the meetings in April, asking myself 'How hard can it be?' Well now I know, although I am very glad to have been useful and supportive to the PCC. All our meetings have taken place via Zoom which is the first challenge if your network coverage isn't 100%!

Coronavirus was a major challenge for all of us. All Churches were closed to public worship. Baptisms and weddings were postponed. All concerts, meetings and any gatherings in the hall were cancelled. Funerals were still taking place with only immediate family attending. The Standing Committee and the PCC members are still having regular meetings and are well attended. Practical things have to be decided upon and things need to keep running as smoothly and ongoing as possible. Several risk assessments have been carried out and as things change, they are updated.



The Vicar knew that there are still ways to reach out to people and with the support of the Committee and other practical people, set up Worship, Prayers and Services for as many people as possible to attend on line through Facebook, Zoom and telephone. These Services have been invaluable to people and are very popular.

Vulnerable people in the village and surrounding areas were identified and contacted regularly. An emergency helpline was set up. Shopping and medications are two of the areas that people have been helped.

The car park at the rear of the Church Hall was resurfaced and the front patched up. The project for creating a Nett Zero Church is still ongoing. Replacing the lighting to a greener and more efficient system is being looked into.

The major good news that happened was our new Curate Jane took up her position with us in July and is a familiar face now as we see her in the online Services and in person when the lock-down was lifted a little for a short time. Her Ordination took place in September. I have joined a very strong and supportive team in the PCC as they continue to keep moving on and meeting further challenges as they appear. We are all looking forward to when we can meet in person in our support of the Church .

The Annual Parochial Church Meeting on Wednesday 18th March 2020 at 7.30pm in Christ Church Coffee Lounge.

The Meeting was attended by Jonathan Winterschladen, Helen Land, Ken Taylor, Rosemary Wheway, Jon Dean, Robin Harmar and was chaired by the Vicar.

The Meeting was held just before the Lockdown began, but many people chose not to come.

Meeting of Parishioners

 Election of Churchwardens. Two nominations have been received for Jonathan Winterschalden – Proposed by Rosemary Wheway, Seconded by Gordon Wood; Helen Land – Proposed by Ken Taylor and Seconded by Jonathan Winterschalden. As these nominations had been received prior to the meeting, they were duly appointed to carry on their roles for a further year.

Annual Parochial Church Meeting

- **I. Apologies** from Tamzin Little, the retiring Secretary who had people unwell in her home so was unable to come. Ken Taylor took the minutes.
- 2. Minutes of the last Meeting on 20th March 2019 had been published in the Annual Report and were accepted by all present as a true and accurate record.

- 3. Matters Arising There were no matters arising.
- 4. Electoral Roll Report. The Following written Report was read out from Vicki Nath, Electoral Roll Officer. Following the annual revision of the roll for 2020, the number appearing on the roll is now 217. This is only a decrease of one. We have had 7 deaths during the year of people on the roll and six additions to the roll. This means there are still a significant number of church members who are not on the roll. Applications for enrolment can be accepted after the conclusion of the annual meeting and throughout the year not just at the annual revision.
- 5. Presentation of the Annual Report 2019. A full and comprehensive report has been made available both as a paper edition freely available at the back of Church and as a PDF Download from the Church Website. The Vicar thanked all the people and organisations represented within the report for al their hard work and commitment. The Report was duly accepted by all present.
- 6. Financial Report and Presentation of Audited Accounts for year end 31st December 2019. Ken Taylor took us briefly through the accounts and Budget for 2020, which had been agreed by the PCC. There were no questions and Ken was thanked for all his work in getting the accounts done so efficiently and looking after the Church Finances so diligently.
- **7. The Vicar's Comments** these have been published this year within the report and are available to read there. The Vicar didn't add further.
- 8. Election of Deanery Synod Members Rosemary Wheway: Proposed by Jonathan Winterschladen and Seconded by Martin Simmons: Nick Land proposed by Gordon Wood and Seconded by Peter Titchmarsh. There were no further nominations, so Rosemary and Nick were appointed for three years and we carry one vacancy.
- 9. Election of the PCC. There were eight vacancies but just 4 Nominations: Peter Tichmarsh, Bev Turner, Ken Taylor and Frances Brown. The aforementioned were duly appointed. Also Rev'd Jon Dean proposed that Rev'd Geoff Jaques be co-opted onto the PCC for a further year, as now required as Geoff is PTO. This was unanimously agreed. We still have four vacancies on the PCC. We are grateful that Frances Brown has agreed to come on to the PCC to fill the vacant role of Secretary.
- **10. Appointment of Independent Examiners** Ken Taylor Proposed that Baldwins be appointed for a further year. Seconded by Rosemary Wheway and all agreed.
- **II. Any Questions** There were no questions for the Annual Meeting, so the meeting closed to enable the Standing Committee to meet regarding the changes happening due to Coronavirus.

Churchwardens' Report


The year began with the first lockdown and the requirement that we stop meeting in the church building for public worship. However, we didn't stop meeting for worship, and we are immensely grateful for Paul's efforts and determination to keep regular services going on-line. Our services have been available on Zoom and Facebook since the start, with people also being able to listen via their phone. Most people have been able to access the services, and we have also welcomed old and new friends from afar. In spite of IT glitches (which became "learning opportunities"), Paul has calmly and efficiently fixed them. We know that a lot of time, effort and practice has gone into achieving this - thank you so much, Paul. From the summer we were able to start meeting in church again, with strict rules about masks, hand sanitization and social distancing in place. The latest lockdown in January has seen a temporary return to on-line services again as COVID-19 cases in Great Ayton increased, but we hope to return to worship in the church building soon.

Another success story has been the blossoming of Prayer for the Day, where about twenty people meet on zoom each morning at 8.45am, with a similar number on Facebook. People are also watching on Facebook later in the day as well, and again this is attracting people from other churches and countries!

We have continued general maintenance to the fabric of Christ Church and All Saints Church. The car park behind Christ Church has been re-surfaced, and a bike rack installed. We haven't been able to paint the outside doors yet, but hope to do that this year. The Lighting Project consultation and planning continues, although slowed down by COVID-19 restrictions. We have also had the annual gutter cleaning and maintenance carried out on Christ Church. All Saints and the Church Hall.

The church silver and other items of value continue to be kept safely. We would normally update our records in January, but have delayed this until lockdown restrictions have been lifted.

There is a large group of people working behind the scenes who enable our church to function, even during this difficult year. This group includes our volunteer cleaners, sides-

REVIEW OF FINANCIAL ACTIVITIES AND AFFAIRS



2020 was a year which many of us will remember for a long time – for all the wrong reasons! In March the Church, along with most of the country, was plunged into a lockdown as we confronted the deadly Covid-19 virus pandemic. Although we managed to open for a short while in the summer, the arrival of a more virulent strain of the virus caused us to lockdown again at the turn of the year. Fortunately, technology came to our rescue as Paul managed to stream services on-line to an enlarged congregation worshipping from the safety of their own homes.

Financially, this had a serious effect on our income – without services in Church we lost a large swathe of collections from casual visitors, weddings and funerals. Fortunately, we are blessed with a large number of planned givers who maintained their giving levels throughout the year. This was particularly true of those who give by envelope- with the help of other members of the finance team we were able to gather up the envelopes from their doorsteps, through letter boxes or from Church when it finally re-opened. A massive thank you to you all for your dedication!

As a result, our unrestricted income fell from the budget of £140,000 to £127,340. Planned giving held up well (only falling by 4% from budget) but loose collections fell by almost £5,000 and fees from funerals and weddings by £2,600.

We had budgeted for a loss of £16,000 for the year to enable some much-needed improvements to be carried out. The rear car park was resurfaced but the project to upgrade the church lighting system had to be put on hold. In 2019 the PCC agreed to increase the Freewill Offer to the Diocesan Common Fund for this year by 4% and we honoured this commitment. We were also able to donate £10,700 from general funds towards a range of local, national and international charities.

With the church being out of action for much of the year, electricity, service costs and administration costs were all below budget. This meant that our losses over the year (excluding the budgeted work on the car park) were restricted to £6,500.

We ran a number of appeals during the year. The Easter and harvest appeals for Middlesbrough Food Bank raised a total of £1,984 and a collection during Christian Aid week raised £827. In October we learnt that St Chad's church in Middlesbrough had been the victim of a lead theft from their roof so we raised £1305 to assist them with the repair.

For our Christmas appeal, we chose to support the Barnabas Fund in a project to supply starving children in Zimbabwe with a nutritious cereal called e-Pap. Normally this would be funded from collections from carol services but with the church closed this was impossible. Instead, we used a variety of giving methods namely cash, direct banking

and an on-line donation platform which proved very successful as a record total of over £4,200 was raised!. Despite use of the church being limited for weddings and funerals, we still managed to raise £29,172 for a total of 38 different charities.

All Saints church was closed throughout the year and fortunately expense was largely restricted to payment of the insurance premium.

The Church Hall was also used in a very limited way. To mitigate expenditure, one of the cleaning staff was placed on furlough and a discretionary grant obtained from the District Council. This enabled the hall to break even over the year, leaving a bank balance at the year end of £2,572.

Despite the losses incurred this year, the balance in our general funds remains at a relatively healthy level of £42,771 which is equivalent to 3-4 months operating costs, in accordance with the policy of the PCC.

In this very difficult year, I am even more indebted than normal to the efforts of our finance team - John & Ynez Clarke, Helen Dickinson and Jean Goat. But most of all, a huge thankyou to all members of our congregations, in person and on-line, local and in some cases far afield, who have helped to keep our church financially stable as we navigate these rough Covid waters! Here's to a calmer 2021!

Safeguarding Report - January 2021

Against the backdrop of Covid-19, very little has changed substantially in terms of our approach to safeguarding at Christ Church. All those who work with vulnerable adults and young people are currently DBS checked and we have added one new church member to those cleared to work with children. Those whose certificates expired during 2020 have been renewed, with 2 dropping off since they no longer work with the church's youth groups. This means that a total of 44 people are currently on our approved DBS checks register.



Training in person has been suspended by the diocese during 2020, so that my booked course linked to risk assessing was postponed until further notice: this is an ongoing action for me to focus on as restrictions hopefully lift in 2021, so that we can work to detailed risk assessments for regular church activities in the future. In the meantime, a few church members have completed online training so that the current number of people with safeguarding training stands at 39, with 16 people having taken more than one level of online courses.

Thank you to all PCC members who have completed this training too: we only have 2 outstanding PCC members yet to complete safeguarding level C0.

Stokesley Deanery Synod

In 2020 the Parish was represented by Nick Land, John Dickinson and Rosemary Wheway. There were 2 vacancies. The clergy also attend.

There was a Synod meeting in February when Revd Nik Stevenson explained how he was available to help all parishes in the Deanery as Multipy Minister. He is based in the parish of St Francis, Ingleby Barwick working to attract people who, at present, do not interact with the church - especially the 20-40s.

The Deanery organised a Come and See mission which began with Lent Services in St Mary's Nunthorpe. These were led by Ven John Day, York Diocesan Mission Strategy Development Adviser, Revd Canon Maggie McLean, Canon Missioner in York Minster and Rt Revd Pete Wilcox, Bishop of Sheffield who launched the Come and See Mission in the Deanery. This was followed by our own Come and See Day on the Saturday before the first Lockdown.



The new Deanery Synod triennial began on 1st July. Revd John Ford retired as Area Dean in the Summer of 2020 and in the Autumn was succeeded by Revd Clay Roundtree.

It has not been possible for the Synod to meet but in October there was a service for members at which the preacher was Ven Dr Amanda Bloor who welcomed the new Area Dean.

Christ Church Visitors

The year began well with three meetings which included one with training in End of Life Care led by Dr Lucy Roth from Teesside Hospice. This was very well presented and led to some challenging and thoughtful discussion.

As soon as Lockdown was inevitable, we held an emergency meeting where we were joined by several other members of the congregation to discuss what we could do, as a church, to help anyone in the village in need of assistance. A daily Helpline was established using the office phone number which was manned for 2 hours each day. 250 cards were printed and delivered to publicise this offering to deliver shopping, collect prescriptions, post letters etc. We are indebted to the small team who undertook these duties.



At the same time the 10 Helpline volunteers were given some names to phone in an attempt to support members of the congregation – especially those who could not access online services. As the Lockdown progressed these members were also given phone numbers to access our weekly Sunday morning services and the number of the Church of England's Daily Hope giving messages, prayers and hymns.

In December a copy of Spire was delivered to people who normally pick up a copy in church with the offer to deliver one in 2021, if needed.

It has been a difficult year but the Visitors continue to be in contact with those they once visited using the phone or posting letters to Care Homes in order to try to stay in touch.

We thank the Helpline Volunteers and those members of the Visitors Group for all that they have done and continue to do.

All Saints Church

2020 was a year like no other. The coronavirus pandemic meant that normal life and every day activities were severely disrupted throughout the year and All Saints was no exception. Thus the church remained closed for the summer season, taking into account the strict covid restrictions together with the safety of visitors and our guides. Apart from the social costs of lockdown, as was the case for many organisations, this left us with no income but continued outgoings, such as £800 insurance, still to pay.

However prior to the latest lockdown we were able to do some socially distanced work on the churchyard, clearing overhanging branches, brambles, nettles and ivy around the Loy memorial and most of the vicarage side. A big thank you to all the volunteers. especially the new ones who took part in this exercise. Coincidentally this ties in with a new churchyard land management scheme linked to a wider church 'eco project', for which some initial virtual planning has been carried out in the past two months.

This is something to look forward to and whilst it remains difficult to make many plans for 2021 we can be hopeful that conditions will soon start to improve to such a point



where a degree of normality can return to life and we can consider a safe reopening of the church.

Bible Reading Fellowship (BRF) brf.org.uk

"Thank you for all the many inspiring writings that help so much when things are tough". The editor published this recent comment sent in from one of New Daylight's many thousands of readers in a recent edition of the notes. There are 34 people at Christ Church who use **New Daylight** to help encourage a habit of daily reading and reflection as part of helping faith to grow. Positive comments came from several members of our group as the readings took us through the season of Creation in September, when a team of scientists (all people of faith) used a variety of passages from both the Old and New Testament to reflect on some of the wonders revealed by science, with the hope that a new perspective could enlarge our view of God as Creator. During November Amanda Bloor (now Archdeacon of Cleveland) invited us into a two week journey of using everyday objects to inspire prayer and as we went into December there was an opportunity with another very different writer to gain new insights into the familiar readings used during the Festival of nine lessons at Christmas. Lots of food for thought on a daily basis.

Guidelines also published by BRF provides a focus for more in depth study. Prayer Report

"Through our lives and by our prayer, may your kingdom come"

During March an unprecedented change for the world unfolded as the Covid 19 crisis spread. With the closure of our church building prayer from our own homes and during "exercise walks" developed

new life. Our personal prayers and thoughtfulness from our own homes continue to be a daily way of loving and caring for others.

Paul quickly established a daily "Prayer for the Day" on Zoom at 8.45am Monday to Saturday. Fifteen minutes spent together, with prayers, a psalm, a short reading and a Thought for the Day ending with the Lord's Prayer. This began with about eight regular attenders but now nurtures on average 50 – 60 people per day, including catch up on the website and Facebook.



Our church building has been able to open for prayer at appointed times during the past year. The poppy display during Oct/Nov and the Memory Tree and Crib in December both provided focus points.

Before Covid on March 6 the well-attended "World Day of Prayer" service, organised by Angela Jaques and a team from each of the village churches went ahead as scheduled in St.Margaret's church. The service had been prepared by Christian women of Zimbabwe and was used by I20 countries and islands from around the world as they each took part during the 24 hour cycle of prayer.

March 14 was Christ Church "Open Day" – organised as part of our response to the York Diocese "Come and See" initiative. During this time seven interactive Prayer Stations based on the Lord's Prayer were set up in church. Throughout the day, on the hour, there was a short time of prayer together.



On the days between Ascension Day (21 May) and Pentecost Sunday (30 May) our Archbishops once again called for everyone to pray for God's Kingdom to come into the lives of people around us. Prayer journals published specifically for this time were available. Many people made prayer ribbons visible outside their homes as reminders of prayer for our chosen five.

The Sentamu Prayer Group are in touch with each other regularly. We are an 'open' group who continue to use the Sentamu prayer

pattern at least weekly to pray for the world, friends, family and each other.

Ann Browne who guided the ecumenical contemplative prayer group invited the Canon Christopher Collingwood, Chancellor of York Minster to speak on Zen Openness and to spend time in meditation together. His visit was well attended when it took place on 20 February in Christ Church coffee lounge.

Ann died on 21 May. She was indeed a prayer warrior and is missed. Her prayer group continue their pattern of regular contemplative prayer times on Monday evenings at 7.30pm and Wednesday afternoons at 4.00pm in their own homes. In September a Zoom meeting with Terry Doyle was organised by our group and well supported. (Terry is a long time practitioner and teacher of meditation, now employed in Middlesbrough working with the marginalised.)

In Nov / Dec. some of our group took part in a series of evening Zoom sessions for the season of Advent with Rev. Mel King which attracted people locally and from other countries.

Little Fishes

After a good start to 2020, Little Fishes was one of the last services to take place in church before lockdown in March. Geoff and I had already decided that, after ten thoroughly enjoyable years of involvement with this venture, it was time to step down even before everything changed. We met lots of village families and hope that the Little Fishes outreach has benefited many on their journey of faith.

Thanks are due to all the helpers over the years – refreshments team, sidespeople, storytellers, leaders, set-up helpers and all who helped in many ways to make Little Fishes a successful service and fellowship event for so many years.

However, it did not stop there as we continued to operate a virtual service via Facebook throughout April to July, either from Great Ayton or Cumbria with good support. A virtual choir was formed with lots of enthusiastic children joining in from their homes singing "This little light of mine" and the Lord's Prayer. Rather surprisingly our income held up well in 2020. We lost regular users and nearly all our one off bookings but the Furlough Scheme helped enormously. Many thanks to Ken for applying and administering this source of income which continues into 2021. A discretionary Small Business grant of £5000 was received via Hamble-

ton District Council, a life saver to businesses like ourselves that saw their income disappear almost overnight, when the first lockdown came into force. As mentioned earlier the 200 club provided a constant source of income, during this uncertain year, which was great help. Please do consider joining if not already a member.

On the expense side we replaced double glazing units in the main hall where their seals had broken, fixed a long standing rainwater drain issue, donated £500 to the carpark resurfacing project and bought some sound muffling screens for the coffee lounge. This last item is to try and reduce the echo heard in the coffee lounge when large numbers of people gather. (They are currently waiting installation by our builder). The stairway to the Upper Room was painted, being the only part of the building not done during the recent renovation project. Those of you who have been into the hall will have noticed many photographs now displayed on the walls of the passageways.

We are most grateful to Jim for providing the beautiful photos, mainly of the church spire taken from his back garden. Finally we are indebted to Phil for repairing and sealing the wooden floor in the Upper Room, a great improvement.

The hall committee, comprising of Helen, Jonny, Ken, Paul, Pauline, Sarah and Vicki, met virtually on three occasions over the year. Very sincere thanks to all the committee for their guidance during this extraordinary year and, to those hall users who managed to make use of the hall in difficult circumstances. Eco Church

At its February meeting the General Synod voted to set new targets for all parts of the Church of England to be Net Zero by 2030.

At the September PCC meeting it was decided to establish an Eco Church Steering Group to put a plan in place. A diagram entitled The Next Step for Churches was shared showing the Energy Footprint Tool, we are currently at category C on the scale. Geoff Jaques, Helen Land, Ken Taylor & Robin Harmar agreed to serve on the Steering Group.

A Rocha has a very helpful Eco Church survey on its website which the Group used to assess our current situation. There are 5 categories in the survey: Worship & Teaching, Buildings, Land, Community & Global Engagement and Lifestyle. The initial results confirmed that we had already made some useful steps in the right direction e.g. the installation of bike racks earlier in the year and suggested a number of ways in which we could make further progress.



- 1. Switch our electricity supply to 100% green
- 2. Convert our lights to LED bulbs
- 3. Establish a Land Management Plan

Having taken steps to progress the first 2 actions the Group held a Zoom meeting with a local Biodiversity Officer to give us guidance on establishing a Land Management Plan. As the land with the greatest potential is All Saints Churchyard we co-opted 2 additional members Robin Hazell and David Fox. We look forward to progressing this further in 2021.

Earlier in the year, as part of the Diocesan 'Come & See' weekend we had worked together with Stokesley Parish Church to organise an evening entitled "Nett Zero: 2030 The urgent challenge of Climate Change, a Christian Response" led by the Bishop of Sheffield, Pete Wilcox and his colleague Rev John Hibberd. This was well attended from across the deanery with a good mix of church members and environmental activists including members of Climate Action Stokesley and Villages.

Following the appointment of Revd Jan Nobel as Green Ambassador for the Diocese, Geoff has been invited to join the newly formed Diocesan Environment Steering Committee.

Marwood Church Of England Infant School continues to thrive in every way.

Foundation Governors' Report to Christ Church P.C.C. January 2021



Lockdown, Academic performance, etc.:

No report on the continuing outstanding success at Marwood School could begin this year without first thanking and paying tribute to Dorothy Walton and her wonderful staff for the unparalleled efforts put in to keep Marwood's academic levels and community atmosphere at the enviable level we have come to expect. Faced with challenges that no-one could be prepared for and often inexplicably day-to-day shifting changes in regulations and demands upon the school, Marwood remains the joyful and high achieving

place that has made us proud for so long.

The arrangements for lockdown have been incredibly thorough and Personal, Social and Emotional Development has been one of the key areas in which imaginative and detailed work has been provided for children learning in school and at home. As well as this, technology has been to the fore and key virtual services – leavers 2020, Harvest, Christmas and the Nativity play - have been streamed to homes, as well as Reverend Peverell's weekly worships being regularly shared with those learning at distance. The general quality of activities for families teaching children themselves has been met with a host of positive responses from parents, and a recent survey home was overwhelming in its praise for the provision and the school's response. Since then even more innovative methods of teaching, including live lessons and the use of TEAMS to share and record work has gone a very long way to compensating for the lack of physical schooling.

The school was very much on course to meet its academic targets when the first lockdown occurred. When the children returned to school in the Autumn, the money from the Covid Catch-Up Fund were put to dynamic use and the process of restoring the pupils to pre-lockdown levels of attainment was embraced with real vigour. The success of this focused support meant that a very impressive 92% of pupils in Year 2 passed their phonics screening test before Christmas, with more likely to follow, surpassing even pre-lockdown expectations. This signals a remarkable ability in the school to ensure that the potentially detrimental effects of 2020 and 2021's academic disruption have been substantially overcome by the school's wonderfully dedicated and talented staff, a most reassuring and noteworthy accomplishment which fills everyone with quiet confidence for the period after the present lockdown ends.

Staffing:

Into this complex mix, have come additional new governors – Mr Neil Skerry (parent governor) and Dr Sara Papworth (Local Authority Rep.) who have rapidly settled into their roles and proved assets to the governing body. Additionally, changes in staffing have occurred with Mrs Pamela Tann (HLTA) and Miss Debra Furlong (Midday supervisor) being welcome additions to the caring atmosphere that distinguishes the school. More challenging still, and with congratulations of course in order, Mrs Emma Anderson has taken maternity leave following the birth of her daughter, Rosie and has been covered in her position as Reception class teacher by Miss Cathrine Gale. This has been an extremely successful appointment as Cathrine has shown wonderful commitment to the Marwood ethos, a real empathetic level of care for the children and outstanding creativity and organisation in the curriculum she has delivered: the new intake could not have had a better start to their education. The school has continued to staff a wrap-around care provision that remains extremely popular with Marwood families

Outside the building:

After the successful creation of our sacred space in the outdoor playground area, the rest of the playground has had a big facelift: beautiful new floor markings, including the new Marwood Mile challenge, have made this a lovely interactive space. The rest of the school has had a lick of turquoise paint too, so that the whole of the outside of school looks very welcoming. Indeed, Dorothy received a personal letter on behalf of the school from Rishi Sunak, M.P. congratulating her on



making the outdoor space such a vibrant setting for the children.

Events and Community Activities:

Whilst some of the usual enrichment activities for the children and contact with the local community has been difficult to sustain over the past twelve months, the school still managed to deliver its Harvest gifts to the residents of the local bungalows. Other traditional activities have continued this year, owing to the staff's resilience and ingenuity, including a wonderful Nativity play which was sent out in video form and brought welcome Christian cheer in the run up to Christmas. The annual rearing of chicks and butterflies was not halted by Covid-19 and regular updates via photos and video clips was one of the many ways the school kept its community feeling as involved as ever.

Newsletter:

The weekly newsletter also continued to celebrate many of the school's classroom events and achievements. Together with the website and Facebook page, it has provided a valuable means of communication for parents while homeschooling during school closures.

Collaboration with Ingleby Greenhow School:

To quote Dorothy in her newsletter at the end of Spring Term 2020, "There has never been more of a time where our school Bible quote of 'Love your neighbour as Yourself' – Matthew 22 v 39 has been so very pertinent for all of us."

One of the positives of 2020 across the country must be the reawakening of community spirit in the face of this pandemic. Since last March, Marwood's links with Ingleby Greenhow Primary School have been further strengthened. During the first lockdown, the schools collaborated to accommodate, care and educate the children of key workers, sharing resources and staff. This proved a popular alliance, with both the children and staff during a very challenging period. Friendships were made that will no doubt continue to grow and enrich for years to come.

Trinity Group

2020 saw two groups of children getting involved in activities designed to promote awareness of global issues such as poverty, injustice and the destruction of the environment in a format that is ageappropriate and enjoyable. Although opportunities have been limited in 2020 and the group had to shrink to remain within the guidelines of class bubbles, the children have nevertheless completed a range of activities. These included making friendship bracelets, Christmas prayer baubles,



experiencing an unjust dinner party, playing random acts of kindness bingo and the offering of their own prayers for their global neighbours. The children are very enthusiastic and keen to share their thoughts and ideas. As class representatives, they are adept at relaying what they have discussed in Trinity Group to their peers during circle time. We continue to build a body of evidence to support us in achieving the Christian Aid Global Neighbours Bronze Award.

Summary

In spite of the health crisis, Marwood has emerged stronger than ever. It remains a very special place where children can thrive both academically and holistically. Dorothy and her team have kept a sense of normality for the children and have been steadfast in dealing with the day-to day challenges they have faced while maintaining high quality teaching standards. What is more, they have approached the changes with rigour and resolve to ensure the safety of the children and adults working within and visiting the school. Parents have been very grateful and supportive of the school and this has been reflected in the complimentary feedback from parent surveys in October. The feedback was unanimously positive, particularly praising the calmness of the staff and their ability to reassure and communicate changes well.

At the same time, as Headteacher, Dorothy has shown prudence and good judgement working well within tight budgeting constraints to ensure the school's financial and administrative health. This level of commitment from both herself and her staff is demonstrative of their professionalism and passion for the school and the community it serves.

Hence it seems fitting to conclude with the words of a Marwood parent, We are eternally grateful for all of the care and support our children have been given in school to adjust to the 'new normal', build resilience and continue their learning all of which we know will make a positive difference to their futures. 


Online - Facebook & Zoom

A brief note on a couple of other services.

The Carol Service Reached 1930 people with 457 Engagements on Facebook and a Peak Live figure of 25 with 58 views of > 1 minute

Midnight Mass Reached 1967 people on Facebook with 414 Engagements and a Peak Live figure of 44 with 191 views > 1 minute.

Other articles in this Annual Report also show the broad range of uses we have made of technology during 2020.

Our final post of the year told 1737 people the Brilliant News that over £4,000 had been raised to feed starving children in Zimbabwe – much of the giving being Online!

Unfortunately, as with most of life at the moment, since March Guiding has been very different in Great Ayton. For most of the year face to face Guiding has not been allowed. 
Brownies started 2020 working on our Live Smart Challenge.

Our charitable giving held up very well in 2020 despite the lockdown having been £31,731 in 2009 and £29,173 in 2029.

This was due to the PCC Giving remaining at the same amount, and also very successful appeals for Middlesbrough Foodbank, St Chad's Church Roof in Middlesbrough and the Christmas Appeal for Zimbabwe.

The main casualties were the charities children's usually supported baptism by collections, as only I took place, and the reduction both in the number of weddings and funerals in Church and the restrictions of those able to attend. We have done as much as possible to encourage Online Giving to the charities as well, as they too will be seeing a downturn in Funds, but would to thank all for their generosity which has enabled a better result than we imagined.

NOTES TO THE FINANCIAL STATEMENTS For the year ended 31 December 2020

1. ACCOUNTING POLICIES

Basis of preparation

The charity constitutes a public benefit entity as defined by FRS 102. The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland issued in October 2019, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities Act 2011 and UK Generally Accepted Practice.

The financial statements have been prepared to give a "true and fair" view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a "true and fair view". This departure has involved following the Accounting and Reporting by Charites: Statement of Recommended Practice applicable in the UK and Republic of Ireland (FRS 102) issued in October 2019 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1st April 2005 which has since been withdrawn.

The financial statements are prepared on a going concern basis, under the historical cost convention, modified to include certain items at fair value. The financial statements are presented in sterling which is the functional currency of the charity and rounded to the nearest £.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

Restricted funds represent donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given .Any balance remaining unspent at the end of each year is carried forward as a balance on that fund. The PCC does not normally invest separately for each fund.

Unrestricted funds are general funds which can be used for PCC ordinary purposes

Income: Planned giving, collections and donations are recognised when received. Tax refunds are recognised when the incoming resource to which they relate is received. Grants and Legacies are accounted for when the PCC is legally entitled to the amounts due. Interest is accounted for when received. All other income is recognised when it is receivable. Incoming resources are generally accounted for gross except fees which are net of amounts paid directly to the Diocese and other third paries

Expenditure: Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The Diocesan freewill offering is accounted for when due Amounts received specifically for mission are dealt with as restricted funds. All other expenditure is generally recognised when it is incurred and is accounted for gross.

1. ACCOUNTING POLICIES (continued)

Fixed assets

Consecrated and benefice property is not included in accordance with S10(2)(a) and (c) of the Charities Act 2011

Moveable church furnishings held by the Vicar and Churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the Church's inventory, which can be inspected at any reasonable time. For anything acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements.

Equipment used within the church premises is depreciated on a straight line basis over 4 years. Individual items of equipment with a purchase price of £500 or less are written off when the asset is acquired.

Investments are valued at market value at 31 December

Looking Forward

This year has been one of great challenges, not just for us, but for everyone the world over as we have had to respond to new circumstances.

Vicars come and Vicars go - eventually - but God's work and the life of the Church goes on. The future will be challenging and exciting. Do you want the thrill of the ride, or are you just content to sit on the park bench and watch others having fun? I know where I want to be.

To gain new vision we need new people with new ideas and energy to step onto the Church Council. Most of the people now on the PCC were actually on it when I arrived, and frighteningly I am still one of the younger members! This is not so at Newton under Roseberry where I am in the older section. Could God be calling you to be involved and help give new energy and direction? We have several vacancies on the PCC and we need the younger generations who belong Christ Church to be better represented. Now is the hour. Can you serve, or do you know a younger person you could encourage and pray for? Start now!
